



## Weekly Lottery terms and conditions

- 1. The cost of each entry is £1. Players may purchase more than one entry, and payment must be in advance. By entering the Weekly Lottery, you agree to be bound by these terms and conditions.
- 2. Not to be sold by or to anyone under 16 years of age or outside Great Britain (this excludes Northern Ireland, Isle of Man and the Channel Islands). Children with Cancer UK reserve the right to confirm that these criteria are met and any person found not to meet these criteria will not be entered into the Weekly Lottery and automatically forfeits the right to any prize.
- 3. Lottery number(s) will be confirmed by post within 21 days of signing up to the Weekly Lottery. No ticket will be supplied.
- 4. The weekly draw will be conducted every Friday. The draw will be conducted by a random number generator.
- The winning numbers will be published on childrenwithcancer.org.uk/lottery and will be available from the Weekly Lottery Helpline on 01628 201282. Results will be available from the Monday following the draw.
- Prizes for the Weekly Lottery are published on the Children with Cancer UK website (childrenwithcancer.org.uk/lottery). There are no alternatives to any prize, prizes are not transferable and no interest will be payable. Prizes will be sent by cheque within 14 days of the weekly draw.
- 7. All lottery players are automatically entered into our Super Draw, twice a year, for the chance to win a prize of £40,000. The Super Draws are in addition to the Weekly Lottery draw.
- 8. All profits from the Weekly Lottery go to Children with Cancer UK.
- 9. Children with Cancer UK is not responsible for any delays in bank payments.
- 10. Players are responsible for providing and (where necessary) updating Children with Cancer UK with their accurate and up to date contact details. No liability is accepted for: any failure or inability to contact a player because of inaccuracies in contact details provided; loss, theft or delayed receipt of any communication sent by post; delays or failures in software or other systems used by Children with Cancer UK or its External Lottery Manager for the administration of the Weekly Lottery; or any event beyond the reasonable control of the Charity or its External Lottery Manager.
- 11. Children with Cancer UK reserves the right to use the winner's name for promotional purposes. These will only be in summary, for example Mrs Jones from Berkshire.
- 12. Children with Cancer UK or its External Lottery Manager may (without giving any reason or notice) decline to accept an application, cancel an existing subscription or terminate or suspend the lottery scheme. Children with Cancer UK operates a Complaints and Disputes Procedure which will be made available to customers upon request. No detail in an application may be changed in any way once it has been submitted, except for a change of address.
- 13. The rules are subject to change by Children with Cancer UK or its External Lottery Manager. The latest version of them will be published on the website childrenwithcancer.org.uk/lottery.
- 14. Children with Cancer UK will collect and process participants' personal information in order to conduct the Weekly Lottery and it will be shared with Children with Cancer UK's agents to the extent necessary for the Weekly Lottery to be administered and the prize to be delivered to the winner. Players' names and other personal details from their entry to the Weekly Lottery will be collected and stored by Children with Cancer UK and held in accordance with the applicable privacy policy in

place from time to time (see childrenwithcancer.org.uk/privacy-policy Children with Cancer UK will send participants marketing materials that they have consented to receiving.

- 15. Children with Cancer UK holds customer funds separate from company funds in a separate account. This means that steps have been taken to separate customer funds from business funds but those funds are not protected if Children with Cancer UK becomes insolvent. This meets the Gambling Commission's requirements for the segregation of customer funds at the basic level of protection.
- 16. These terms and conditions are governed by English law. The courts of England and Wales shall have exclusive jurisdiction to hear any dispute or claim arising in association with the Weekly Lottery or these terms and conditions.

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits. If there are any changes to the amount, date or frequency of your Direct Debit Children with Cancer UK will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request Children with Cancer UK to collect a payment, confirmation of the amount and date will be given to you at the time of the request.

If an error is made in the payment of your Direct Debit, by Children with Cancer UK or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when Children with Cancer UK asks you to. You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
