- If an error is made in the payment of your Direct Debit, by Children with Cancer UK or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- - If you receive a refund you are not entitled to, you must pay it back when Children with Cancer UK asks you to.
