## **Children with Cancer UK Terms & Conditions**

## Richmond RunFest 2026 - Charity Place

Please note that **Children with Cancer UK** has a limited number of places in the **Richmond RunFest 2025**, taking place on **Saturday 12 September & Sunday 13 September 2026**. Places are given on a first-come, first-served basis. The following terms and conditions apply to those securing a charity place.

- For this event, we require a registration fee of:
  - £30 (+VAT) for the half marathon
  - £35 (+VAT) for the marathon
  - £25 (+VAT) for the 10K
- These fees are non-refundable and non-transferable and must be paid upon completion of the charity place registration form.
  - In addition, you endeavour to raise a minimum of:
    - £250 in sponsorship money for the 10K
    - £350 for the half marathon
    - £450 for the marathon
    - In addition, you will endeavour to raise the fundraising pledge. Sponsorship should be received by **Children with Cancer UK** by the **end of December 2026**.
- We recognise that fundraising happens both before and after the event. However, most fundraising is typically completed prior to the event.
   To help you stay on track, we request the following milestones:
  - At least 75% of your target (excluding Gift Aid) by event day (Saturday 12 September/ Sunday 13 September 2026), unless otherwise agreed
  - The remaining 25% by the end of December 2026.
- Fundraising progress will be reviewed regularly to provide support, but failure to demonstrate active fundraising efforts may result in your place being forfeited. If delays occur, please contact us at **sports@childrenwithcancer.org.uk** to discuss further.
- Charity places cannot be deferred to the following year.
- You will be required to complete a registration form on the entry registration system for the organisers (the 'console'). Failure to complete this form by the given deadline will result in loss of your place, and your registration fee will not be refunded.
- You confirm that you are medically fit to participate and do so at your own risk. Children with Cancer UK will not be held responsible for any injury or illness resulting from your participation in the event.
- You understand it is your responsibility to read and comply with any terms and conditions issued by the race organisers.
  - The minimum age for this event is **18 years old**. You confirm you will meet this age requirement by race day (Saturday 12 September/ Sunday 13 September 2026).
- You acknowledge that Children with Cancer UK may incur costs as a result of you joining the Children with Cancer UK Team (e.g. cost of producing and sending fundraising pack/technical kit) for this event.
- All participants understand that any products distributed at the event are subject to availability and may be withdrawn or substituted if necessary.
- As the event is external to Children with Cancer UK, Children with Cancer UK shall not be liable for any loss or damage that participants suffer as a result of taking part in the event.
- Should you, for whatever reason, not take your place, all sponsorship forms and monies collected should be forwarded to Children with Cancer UK or returned to your sponsors.
- You have provided Children with Cancer UK information about you and consent to Children with Cancer UK using this data. You
  understand that it will be necessary for Children with Cancer UK to share the data with the race organiser in order for you to
  participate in this event.
- We do not sell or swap your details with any third parties, but in order to carry out our work we may need to pass your details to service companies authorised to act on our behalf.
