



## **Children with Cancer UK Terms & Conditions**

### **Altra Yorkshire Marathon 2026 – Charity Place**

Please note that Children with Cancer UK has a limited number of places in the 2026 Altra Yorkshire Marathon, taking place on Sunday 18 October 2026. Places are given on a first-come, first-served basis. The following terms and conditions apply to those securing a charity place.

#### **Registration Fees**

1. For this event, we require a registration fee of:
  - a. £35 (+VAT) for the Marathon.
2. These fees are non-refundable and non-transferable and must be paid upon completion of the charity place registration form.

#### **Fundraising Targets**

1. You endeavour to raise a minimum of:
  - a. £350 in sponsorship money for the Marathon.
2. This sponsorship money should be received by Children with Cancer UK by the end of January 2027.
  - a. We recognise that fundraising happens both before and after the event. However, most fundraising is typically completed prior to the event.
3. To help you stay on track, we request the following milestones:
  - a. At least 75% of your target (excluding Gift Aid) by event day (Sunday 18 October), unless otherwise agreed.
  - b. The remaining 25% by the end of January 2027.

#### **Cancellations and Deferrals**

1. Fundraising progress will be reviewed regularly to provide support, but failure to demonstrate active fundraising efforts may result in your place being forfeited. If delays occur, please contact us at [fundraising@childrenwithcancer.org.uk](mailto:fundraising@childrenwithcancer.org.uk) to discuss further.



2. Charity places **cannot** be deferred to the following year.
3. You will be required to complete a registration form on the entry registration system for the organisers (the “Console”). Failure to complete this form by the given deadline will result in loss of your place, and your registration fee will not be refunded.
4. Should you, for whatever reason, not take your place, all sponsorship forms and monies collected should be forwarded to Children with Cancer UK or returned to your sponsors.

#### Health and Safety

1. You confirm that you are medically fit to participate and do so at your own risk. Children with Cancer UK will not be held responsible for any injury or illness resulting from your participation in the event.
2. You understand it is your responsibility to read and comply with any terms and conditions issued by the race organisers.
3. The minimum age for this event is 18 years old. You confirm you will meet this age requirement by race day (Sunday 18 October 2026).
4. As the event is external to Children with Cancer UK, Children with Cancer UK shall not be liable for any loss or damage that participants suffer because of taking part in the event.

#### Data Protection and Privacy

1. You have provided Children with Cancer UK information about you and consent to Children with Cancer UK using this data. You understand that it will be necessary for Children with Cancer UK to share the data with the race organiser for you to participate in this event.
2. We do not sell or swap your details with any third parties, but to carry out our work we may need to pass your details to service companies authorised to act on our behalf. For further information, please see our privacy policy: <https://www.childrenwithcancer.org.uk/privacy-policy/>.
3. We will keep your details on our database so we can provide you with the best possible support every time you contact us.
4. All participants, supporters and spectators, including friends and families who choose to attend the event confirm that they are happy for their names, video



footage, photographs taken of them during the event to be used to publicise the event by Children with Cancer UK for commercial and fundraising purposes including, but not limited to marketing material, television broadcasts, social media, advertising, publications, and other documents or mediums that may be made available to the public.

- a. Photographs of children will not be used in this manner without express written consent, unless the images are incidental.

#### Miscellaneous

1. You acknowledge that Children with Cancer UK may incur costs because of you joining the Children with Cancer UK team (e.g. cost of producing and sending fundraising pack/technical kit) for this event.
2. All participants understand that any products distributed at the event are subject to availability and may be withdrawn or substituted if necessary.
